Re: Solid Waste Transporter Registration and Solid Waste District Fees

Solid Waste Hauler,

The Boone County Commissioners adopted Ordinance 2013-04 requiring solid waste transporters as defined in the ordinance to obtain a registration each year if solid waste hauling services are rendered within Boone County. The Boone County Solid Waste Management District acts on the Commissioner's behalf as the registering entity through an interlocal agreement. The Boone County Commissioners adopted Ordinance 2019-03 to require the District fee be a separated line item on each solid waste bill to ensure transparency of the District fees and services rendered for those fees. The Boone County Solid Waste Management District Board approved Resolution 17-01 regarding the solid waste management fees.

Please review and remit the following to the District office to obtain and retain your annual transporter license:

Annually

- Complete and submit the "Solid Waste Transporter Registration Application."
- Issue \$100 solid waste transporter registration fee payable to the Boone County Solid Waste Management District. The fee will be passed onto and retained by the Commissioners after the registration is processed by the District.
- The District will issue a "Transporter License" once it is determined that all requirements are fulfilled.

Monthly

- Transporter is to collect and remit monthly, the District Solid Waste Management Fee set by the District Board of Directors. The District Solid Waste Management Fee is currently set at \$0.40 per residential account per month, \$0.40 per cubic yard per haul for commercial/industrial accounts and \$0.50 per ton for cleanfill disposal tipping fee.
- Complete and submit the monthly "Special Assessment Report."

The Boone County Solid Waste Management District appreciates the public private partnership with your company. Please know that the District advocates for reduction and proper disposal which includes referring our residents and businesses about the services your organization provides throughout Boone County.
